## PEOPLE BEFORE COUNCIL:

-Jeannie Jeffers felt that a qualified police dept. was needed. She felt that she had been harassed by them in an incident with her children. She stated that Chief Muck was very courteous when he later spoke to her on this matter. Chief Muck gave brief summary of incident.

-Betty Folk wants cuts somewhere else. She stated that no one wanted the job so the Village trained these men on tax payers monies so why should we lose them. She also felt that the Police & Street levies should never have been taken off. She did not want officers laid-off. Chief Muck stated that the officers had cut back on time and were only answering calls & complaints. He stated that he would like to have a budget to work with.

-Kathy Hartranft wanted to know which ordinance stated that the Mayor had authority over Police Dept. & which ordinance says that you cannot pass an opinion poll without Mayor's approval? She submitted a poll to keep the Police Dept which had 71 names.

-Marty Herron submitted an additional poll with 56 names to keep the police Dept. Some comments which had been made to her during her polling were: people wish to see more patrolling done, that the town was going down-hill, that there was a mess behind the Village Building, and that they had heard that the officers had been fired.

-Mrs. Ron McCall stated that her garage had been broken into twice and attempted 4 times since. Every one of her calls has been answered promptly. She said it took the Sheriff an hour to arrive.

-Bob Hartranft stated that in the case of the boys throwing sticks at the barn that the sticks were much longer than a cue? stick which officers carry which can bring down a man. The incident with the toys on the sidewalk was discussed. The reason for the officer being out of uniform was that the children were on the street and in danger. There is an ordinance stating that toys are allowed on sidewalks except for sidewalks on Main St. or in the Business District. Chief Muck stated that as long as the officers have their identification they do not need to be in uniform.

-Vernon Furness wanted to know how many tickets have been issued this year. none. Why were none written when people speed through town? Chief Muck explained that they were trying to warn first time offenders that were caught but would write tickets to anyone who abused this courtesy.

-Dick Wharton wanted to know how much money was going to be needed to run the Village. An income tax was mentioned as a solution. Mr. Wharton asked that no matter what the solution that the Village not ask for more than was needed. He also stated that he thought that the Village needed more than one officer and would like to see them patrolling at night.

-Marty Herron asked why two workers could be afforded to sweep the streets when there was no money for the Police? Street fund has to be used for Street repair and maintenance only. The Street Fund is not in a bind.

-Mrs. Muck asked that we see what can be done before Nov. to get on issue on the ballot to raise the money. She asked about getting a levy put on. We Hope to have it on the Nov. ballot.

Mayor is Chief Law Enforcement Officer. He is to see that Ordinances and Resolutions of State & Village are enforced. Chief of Police is the "boss" of his employees and responsible for day-to-day details. Mayor need not be involved in every day incidents. Mayor does have some (supervisory) authority, but day-to-day operation is Chief of Police's responsibility. Mayor hired the Special Deputies but the Chief of Police & Officers now were hired by Council. Laying them off is questionable but they cannot be fired unless for a good cause. They cannot be randomly removed. When complaints are called in on officers, report them to the Council. If it is neglect, then formal notification is given to officer. Then notice of formal charge will be given. Removal of officers is Mayor and Council's responsibility. One Council member stated complaints should be taken to Chief, then if it is serious, it should be brought to Council. \*Betty Folk ask if Chief need to report daily to the Mayor. No, he should keep a report of activities but not report daily. \* Chief Muck stated that the officers have not been patrolling only answering calls & complaints. What does it matter who goes? someone is going to get paid. He reported that it does not cost any more for 3 officer than for 1. Telephone costs run 39.30 a month. Mayor asked about Hartranft not talking to him and was asked in return if he tried to talk to Hartranft. Chief stated that he will not take responsibility of Village safety on his own. \* Betty Folk stated that she felt that Council runs the Town not the Mayor. She came to Council about income tax last year and asked that they start low, and leave the police & street levies on. Now these officers have been trained on tax monies, passed the schooling with flying colors, but because of conflicts are going to be removed. What difference does it make who answers calls, we have to pay them. If sheriff is near, they are great but the Village wanted a police dept. They passed their schooling, give them a budget and let them decide the hours. She asked if an unconditional gift can be donated to the Village for police protection. as long as no strings are attached. \* Kathy Hartranft asked if the Mayor, as Executive Chief of Police, had arresting authority. Any citizen can do that. She asked if he could tell people to get trash off sidewalk or to tie up dogs. He has two options 1) say something to property owner, 2) tell police to take care of the situation. She also asked if the Village had the Green River Ord. on its books. Village has some sort of Ord. on soliciataion. Would you define Soliciting? It would depend on wording of Ord. Does it include taking a public poll or survey? Is taking such poll or survey illegal? Do they need permission from Mayor to go door to door? Depends on wording of Ord. To prohibit door-to-door polls on public issues could be bordering on unconstitutional. As far as we know, Ordinances on books are constitutional. She stated that the definition she found stated "asking for money or sex." She wanted to know if the Ord. & Resol. books should be in the Municipal Building. Yes, and they are working on a way to get them there..

To The Village Council Of Amanda

It is very apparent that the majority of the citizens of Amanda want to continue the police protection offered by Police Chief Muck and his two deputies. Police Chief Muck, has advised that he and the two deputies can provide sound adequate protection if allowed a total of 120 man hours per month (fourty hours per man). This would result in monthly salaries of \$620.00 or less. A total of \$4,960 more for the remaining 8 months of 1984. This means that the village will need to put an additional amount of \$4,775 in the wages and salaries portion of the police fund. The contractual services (phone) and other operation and maintenance funds are now showing a total balance of \$1146.03. Allowing \$100.00 per month for operations and maintenance (supplies and cruiser expenses) and \$39.00 per month for the ~~three~~ phones, there will be no need to increase this portion of the police budget. The 1984 budget for the police department was set in November of 1983, salaries and wages \$1500.00, contractual services \$250.00 other operations and maintenance \$1439.00 totaling \$3,189.20 which was the balance of the police fund as of December 31, 1983. Through April the expenses for this department was \$1857.97 with \$185.00 left in salaries/wages portion. This means that \$1315.00 was spent in the first four months on wages and salaries which figures to be less than 260 police man hours. This is an average of less than 15.5 man hours per week. Given that there are 168 hours in a week the total paid police hours protection average has been less than 9.3% of the time. This, I feel is totally inadequate.

Given that the general fund has a balance of \$13824.58 with an additional income of over \$9,000.00 coming in this year in property taxes and over \$2,000.00 coming in this year from estate taxes and over \$6,000.00 more coming in income taxes now, which will give the general fund a total of over \$30,824.00, I would think that it would be in the extreme best interest of the Village for the Council to reappropriate from the general fund the additional monies needed to maintain our police department for the remainder of the year.

This transfer of funds can be simply done by filing an amended certificate of estimated resources with the county auditor.

It is also legal to gain additional funding from donations throughout the year and use them for village operations within the same year.



I for one would be very happy to provide a very generous donation to be used for police funding if council, after its serious analysis of the general fund budget, determines that it cannot afford to use the general fund monies to extend the critically needed police protection in this town.

Last year's general fund expenditures were \$30,858.00 of which a total of \$6,745.97 was used for police protection. So far this year no money from the general fund has been used for police protection.

Action must be taken now to prevent the loss of the talent we have in the department and all the money it took to train and equip them. We don't have the time or the money to start all over again.
